James Valley Christian School is seeking a qualified and mission-driven Secondary English Teacher to instruct students in grades 7–12 in literature, composition, grammar, and related language arts. The ideal candidate will integrate biblical truth with academic content, fostering critical thinking, effective communication, and a love for learning within a Christ-centered classroom environment. This position requires a teacher who is committed to academic excellence, biblical integration, and partnering with families in Christian education.

Position Responsibilities

The High School English Teacher will:

- Develop and deliver standards-aligned English/Language Arts instruction for grades 7–12
- Integrate a Christian worldview into curriculum, instruction, and classroom discussions
- Design and implement assessments to measure student progress and inform instruction
- Maintain a structured, respectful, and engaging classroom environment
- Provide timely feedback on student work and communicate progress with parents/guardians
- Collaborate with faculty and participate in school meetings, professional development, and events
- Support and actively participate in the spiritual life of the school, including chapel and prayer
- Uphold and model the school’s statement of faith, mission, and core values

Qualifications

- Bachelor’s degree in English, Education, or a related field from an accredited institution
- Applicants must meet South Dakota educator certification requirements or be eligible to do so. This includes:
 - Holding or qualifying for a valid South Dakota Educator Certificate (Secondary Level, grades 7–12)
 - Completion of a state-approved teacher preparation program, including supervised student teaching/field experience
 - Passing scores on required state-approved certification exams (e.g., Praxis or equivalent assessments)
 - Completion of, or eligibility to complete, the South Dakota Indian Studies requirement as mandated by state law
 - Possession of (or eligibility for) an English/Language Arts endorsement appropriate for secondary instruction (grades 7–12)
- Candidates who are eligible for alternative or provisional certification pathways under South Dakota law may also be considered.

Spiritual Requirements

- A personal, growing relationship with Jesus Christ
- Agreement with James Valley Christian School's Statement of Faith
- Active participation in a Bible-believing church

THE MISSION

The mission of James Valley Christian School is to provide a Biblically based education, transforming hearts and minds to impact the world for Christ.

CORE VALUES

The core values of James Valley Christian School are those pillars upon which this institution is built and continues to endure. They are timeless, fixed and fundamental truths we as a school determine to hold to whether they are practical or popular. In the fluidity of postmodern culture, these values ensure our integrity in changing and turbulent times. Core values are different than principles of operation, procedure and methods which all must change from time to time.

CHRIST-CENTERED: We are a *Biblically based*, evangelical school whose mission, teachers, administration, and methods center unapologetically on a commitment to the grace of God in Christ and the authority of the Bible. We are committed to the authority of the Bible as the inspired Word of God. How we as a community define this evangelical faith is articulated in the James Valley Christian School Statement of Faith.

ACADEMIC EXCELLENCE: Our goal is to offer an excellent *education* which inspires students to reach their full potential and enables our faculty to teach to a higher standard. We are committed to educating students in a rigorous curriculum, grounded in Biblical faith. We desire that our students become lifelong learners of truth and lifetime lovers of God and His Word.

SPIRITUAL DEVELOPMENT: *Transforming hearts and minds* to the image of Christ is the goal of Christian education. It is our privilege to teach young people who they are in Christ, how God has gifted them and how to effectively serve God with their knowledge, skills, and wisdom. In order to be used of God for His purpose, our students must be spiritually equipped to resist Satan, his attacks and evil schemes.

COMMUNITY: We exist as a school to support parents in their biblical mandate to nurture their children in the fear and admonition of the Lord. James Valley Christian School will support a school community that is disciplined, loving, wholesome and safe. We will endeavor to aid parents in raising up a generation that will *impact the world for Christ* while serving in their community, church and beyond.

James Valley Christian School Doctrinal Statement

1. We believe the scriptures, including both the old and new testaments, to fully be the verbally inspired Word of God, written by men in God's control, inerrant and infallible in the original manuscripts and the final authority in faith and life. (II Timothy 3:15-17, II Peter 1:20, 21; Psalm 19:7-9)
2. We believe in one God, eternally existing in three persons: Father, Son, and Holy Spirit. (Deuteronomy 6:4; Matthew 28:19, II Corinthians 13:14)
3. We believe that the Lord Jesus Christ, the eternal Son of God, became man, without ceasing to be God, having been conceived of the Holy Spirit, and born of the virgin Mary, in order that he might reveal God and redeem sinful man; that he accomplished our redemption through his death on the cross as a sinless and substitutionary sacrifice; and that our redemption is made sure to us by his literal physical resurrection. He is presently exalted at the right hand of the Father, interceding on our behalf. (John 1:1,2,14; Luke 1:35; Romans 3:24; I Peter 1:3-5; Hebrews 10:10-14; Hebrews 7:25)
4. We believe that the Holy Spirit is the divine person who convicts the world of sin; that He alone brings new life to those who are spiritually dead; that he baptizes all true believers into the true church, which is the body of Christ; that he indwells them permanently, seals them unto the day of redemption, bestows spiritual gifts upon them, controls those who are yielding to Him. (John 3:3-8; 16:7-11; I Corinthians 12:13; John 14:16,17; Ephesians 2:8,9; 4:30; I Corinthians 12:7-11; Ephesians 5:18; Titus 3:5,6)
5. We believe that the creation of the world was an instantaneous and supernatural act of God by which he brought the universe and all that it contains into existence. Man is a direct creation of God—spirit, soul, and body—not in any sense the product of animal ancestry, but made in the divine image. The Genesis account is the trustworthy, historical record of creation. (Genesis 1:1,2,26,27,31; Exodus 20:9,11; Colossians 1:16; I Thessalonians 5:23)
6. We believe that man, a direct creation of God, was originally sinless and in perfect fellowship with God. By personal disobedience to the revealed will of God, man became a totally sinful creature, inherited a sinful nature, and became alienated from God and of himself has no possible means of recovery or salvation. (Ephesians 2:1-3,12; 4:18; Romans 1:18-32; 3:10-23; 5:12; John 8:42-44)
7. We believe that salvation is a free gift of God's grace, offered to us on the basis of Christ's substitutionary death on the cross. It is received personally by repentance for sin and faith in the Lord Jesus Christ, and is in no way obtained or increased by human effort. (John 3:14-18; Acts 20:21; Romans 6:23; Ephesians 2:8,9; Titus 2:11-14)
8. We believe that Satan is a real person, the enemy of God and man, the god of this present world; that he was defeated at the cross, and his eternal doom is sealed. (Matthew 4:1-11; John 12:31; 16:11; Revelation 12:9,10; 20:10)
9. We believe in the imminent, personal, and physical return of the Lord Jesus Christ, to take His church to be with Him, and that He will physically, literally return to this earth to set up His reign which is prophesied in the Word of God. (Acts 1:11; I Corinthians 15:51-57; I Thessalonians 4:13-18; Titus 2:14; Revelation 3:10; 19:11-16; 20:1-6) We also believe in the bodily resurrection of all men, the saved to eternal life, and the unsaved to eternal judgment and everlasting punishment. (Matthew 25:46; John 5:28,29; 11:25,26; Revelation 20:5-13)
10. We believe that God created marriage in the beginning, as a blessing for both man and woman, before any sin or rebellion entered the world, and that he created marriage to be between one man and one woman, who enter into a covenant relationship, complement one another, serve one another, and sanctify one another for as long as they both shall live. Accordingly, we reject any attempt to redefine marriage as a union between people of the same sex or as between more than one man and one woman. We believe that the homosexual lifestyle and alternative gender identities are contrary to the Bible. (*Gen 1:27-28; 2:15-24; Lev 18:22; Lev 20:13a; Matt 19:4-6; Rom 1:26-27; 1 Cor 7:14*).



DECLARATION OF MORAL INTEGRITY

James Valley Christian School expects all of its employees with access to children to model the same Christian values and lifestyle that it seeks to inculcate in its students. As an applicant for employment with access to children at **James Valley Christian School** and its ministries, I, _____ recognize, understand, and agree to live by the moral standards of the school.
