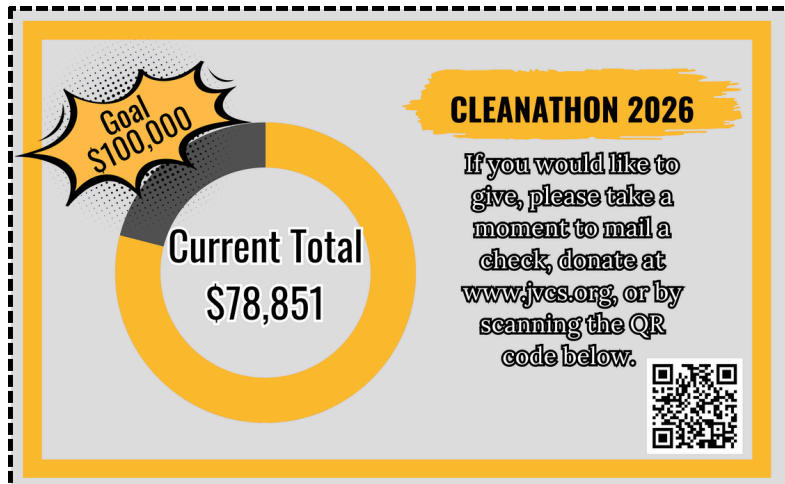

Executive Committee Takes Nominations

The Executive Committee is seeking nominations from corporation members to serve as at-large representatives on the Advisory Board. The Constitution (Art.
